NONEXCLUSIVE LICENSE AGREEMENT

This Agreement is made between the FEDERAL EVIDENCE REVIEW and FederalEvidence.com (collectively “The Review”) and the author [identified in Section 14, below] (“the Author”).

1. Author’s Grant Of Rights

The Author grants to The Review a nonexclusive license to edit and to publish a work (the title of the Article designated in Section 14, below) in the FEDERAL EVIDENCE REVIEW (“The Review”), and on any electronic data base maintaining or distributing the content of The Review, including but not limited to the Web Site: FederalEvidence.com. As part of this license, the Author gives The Review the exclusive right of publication in English. This right of first publication constitutes a worldwide, nonexclusive, royalty-free license from the Author to allow The Review to permit:

- (a) Others to make copies of the Article for any use;
- (b) Others to create abstracts or derivative works of the Article;
- (c) Secondary publishers to reproduce the Article in any form, including on electronic on-line databases and document delivery systems (including, but not limited to electronic reproduction of the Article by Lexis, Westlaw, and by any other electronic means); and
- (d) Others to reproduce the Article or to use only a portion of the Article in all of the aforementioned situations.

2. Duration

This license will endure for the entire term of the copyright in the Article in all media.

3. Author’s Reservation Of Certain Rights

- (a) By retaining the copyright to the Article, the Author retains the following rights among others:
 - (i) To reproduce the Article for use in the Author’s activities in either paper or electronic form, and
 - (ii) To publish the Article or permit it to be published by other publishers.
- (b) The terms in Section 3 (a), are subject to the requirement that the Article shall be cited as follows: “Originally published in the Federal Evidence Review: [volume number, page number, issue month and year; example: 5 Fed. Evid. Rev. 1 (January 2008)].”

4. The Review's Responsibility

The Review is responsible for the dissemination of the FEDERAL EVIDENCE REVIEW, and for the content of the Federal Evidence Review. The Review agrees to publish the Article in the FEDERAL EVIDENCE REVIEW. In addition, The Review will send the Author an electronic copy of the published version of the Article at the time of publication as part of The Review's normal publishing operations.

5. Author's Remuneration

The Author will receive no payment from The Review for the use of the Author's Article. The Author will receive a PDF copy of the issue in which the Article appears. In its sole discretion, The Review may provide the Author a limited, complimentary subscription to the FEDERAL EVIDENCE REVIEW.

6. Author's Warranty

(a) By signing this agreement the Author warrants the following:

(i) The Author has the full power and authority to enter into this Agreement;

(ii) The Author's Article does not infringe any copyright, nor violate any proprietary rights, nor contain any libelous matter, nor invade the privacy of any person;

(iii) No right in the Article has in any way been sold, mortgaged, or otherwise disposed of;

(iv) The Article is free from any liens and claims;

(v) Permission has been obtained to reproduce the Article (or any material within the Article, including the Article's text, any images, photographs, or illustrations) in The Review or in any subsequent reuse or license of the Article by The Review, including electronic rights, if the foregoing has previously been published or created in whole or in part;

(vi) Any permission fees associated with the reproduction of the Article and/or any additional material in the Article have been fully paid;

(vii) The Author has submitted a copy of any permission letters and receipt of any, and permission fees paid as appropriate, in addition to text for credit lines, with the Article manuscript;

(viii) The Article is original and that the Author is its sole author and owner; that neither the Article nor any part of it has been previously published. (For purposes of this paragraph, making a copy of the Article accessible over the Internet, including, but not limited to, posting the Article to a database accessible over the Internet, does not constitute prior publication so long as the copy indicates that the Article is not in final form, such as by designating such copy to be a "draft," a "working paper," or "work-in-progress."); and

(ix) The Article contains no libelous or otherwise unlawful material and does not infringe any proprietary right at common law or any statutory copyright; and that the Author will hold harmless and indemnify The Review against any and all suits, claims, demands or recoveries, including damages, costs, expenses, and attorney's fees, which may be made, taken, or incurred at any time against The Review which are based on either violation of proprietary right or copyright laws, or libelous or injurious matter in the Article.

(b) The foregoing warranties apply only to the Article submitted and revised by the Author and not to any revision made by The Review, its agents, or its successors, or assignees.

7. Editing The Article

The Author and The Review agree to collaborate and cooperate in preparing the Article for publication. The Author agrees to make all revisions reasonably requested by The Review within publication timelines established by The Review. In order to meet publication deadlines, if the Author fails to timely provide the corrections

deemed necessary by the date set by The Review, the publication process will proceed without the Author's approval and the Author's consent to do so will be deemed given. In addition, the Author acknowledges and agrees that The Review has the right to make the revisions necessary, in its discretion, to bring the Article in conformance with the standards of scholarly legal publishing and the standards of The Review. The Author understands that The Review retains all final editorial discretion and decisions.

8. Right Of Withdrawal

The Review reserves the right to withdraw the Article from the publication process at any time prior to publication (a) within the sole discretion of The Review or (b) for specific reasons explicitly made known to Author. The reasons may include, but are not limited to, mootness, substantive errors of law, plagiarism, non-originality, or the failure to meet deadlines. After the Article is submitted, the Author reserves the right to withdraw the Article from the publication process only if The Review's corrections so drastically alter the content, style, and presentation of the Article, that the Article can no longer be deemed to be the work of Author.

9. Author's Indemnification

The Author agrees to hold The Review, its officers, agents and employees harmless from any claim, action, or proceeding alleging facts that constitute a breach of any warranty enumerated in this Agreement and further agree to indemnify and hold harmless The Review, its officers, agents, and employees against expenses and attorneys' fees that may be incurred as a result of any claim, action, or proceeding.

10. Governing Law

This Agreement shall be construed and enforced in accordance with the laws of the State of California. The parties agree that venue shall lie in Contra Costa County, California.

11. Arbitration

The Parties agree that any controversy involving the construction or application of any terms, covenants or conditions of this Agreement, or any claims arising out of or relating to this Agreement or the breach thereof will be submitted to and settled by final and binding arbitration.

12. Savings Clause

Should any of the provisions of this Agreement be determined to be invalid by a court or government agency of competent jurisdiction, it is agreed that such determination shall not affect the enforceability of the other provisions herein.

13. Amendments

This agreement constitutes the entire understanding of the parties and may only be amended in a written agreement signed by both parties.
