The following chart lists all Fifth Circuit (and Selected District Court) opinions issued since January 1, 2007 that cite to Internet addresses. Because some links found in court opinions change over time or disappear altogether, this list is provided to closely capture, to the degree possible, what the court was referencing at the time the opinion was released. Webpages cited in opinions issued between January 1, 2007 - June 15, 2007 were captured on June 18, 2007.

Using the URL referenced in the opinion, the original copy is saved with a watermark to denote the document's archived status. No attempt has been made by the Fifth Circuit Library to determine if any changes have been made between the last date the court visited the page and the date the Library archived the page.

The opinions are arranged in alphabetical order by case name. Click on the document description to retrieve the archived copy of the website. Copy and paste the URL in your browser to link to the current site. Note: not all addresses listed may still be active.
